ACTIVITY

REMAPPING TRANSIT

🕒 45 MIN

OBJECTIVE

To think critically about the politics of mobility and to shift our understanding of "roots" and "routes" as lines and flows but as desires, feelings and lived experiences.

STEP 1

Look at IOM and Frontex maps of migrant and refugee flows "in transit" to Europe.

Answer the following questions:

- What can you see on these maps?
- What is missing from these maps?
- What is the purpose of these maps?
- Where are the people and where/what are the borders?
- What are the keywords and first sentences that come to your mind in relation to movement after having observed these maps?

STEP 2

Reflect on your own experiences of movement across borders. Create a map of these movements.

STEP 3

In small groups of two to three, present each other maps and reflect on the similarities and differences.

STEP 4

Group discussion: Compare your own maps to the IOM and Frontex maps and elaborate on the idea/concept of "transit" as it is being represented in your maps in comparison to the official ones (IOM and Frontex maps).

ACTIVITY

WHAT'S THE POWER OF YOUR PASSPORT?



OBJECTIVE

To think critically about the politics of mobility, to question our relation to the passport that we hold, to detach yourself from our passport.

STEP 1

- Reflecting on the notion of 'stuck in transit', think about the role of "powerful passports" in everyday life, besides the moment of border crossing and travel.

STEP 3

"I am my passport": Reflect on this statement. Do you agree or disagree? Share your perspective in a group discussion.differences.
